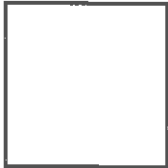

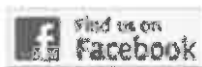

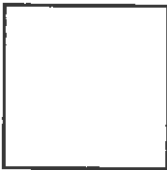

Good afternoon. I spoke with Senator Jon Woods and Mr. Kevin Anderson via telephone and they have pointed me in your direction for assistance. I am the Assistant Director at the Northwest Arkansas Economic Development District (NWAEDD) and recently we received our General Improvement Fund Disbursement paperwork. This morning I was completing that paperwork and was going to give it to my executive director for his signature when I noticed what I think may be an error. Our paperwork (attached above) references Act 418 (SB324) for \$40,000.00. However, when I looked that specific act up it referenced the Arkansas World Trade Center, and not NWAEDD. I believe our paperwork should instead include Act 416 (SB322) for \$40,000.00 which was intended for NWAEDD. If that is accurate, I would assume that we will need a corrected version of the GIF Disbursement paperwork that references Act 416 for us to complete. Having said that, I will wait to hear back from both of you to confirm that.
